

**Health Professions (Pharmacists Council of Zimbabwe) (Registration)
(Amendment) Regulations, 2015 (No. 2)**

IT is hereby notified that the Minister of Health and Child Care has, in terms of section 145 of the Health Professions Act [Chapter 27:19], approved the following regulations made by the Pharmacists Council:—

1. These regulations may be cited as the Health Professions (Pharmacists Council of Zimbabwe) (Registration) (Amendment) Regulations, 2015 (No. 2).

2. The First, Second, Third, Fourth and Fifth schedules of the Health Professions (Pharmacists Council of Zimbabwe) (Registration) Regulations, 2002, published in Statutory Instrument 175 of 2002, are repealed and the following are substituted—

- (b) within the second month after due date plus 20% of the approved fees;
- (c) after the third month (within the first six months) double the current practising certificate fees;
- (d) after six months and over double current practising plus re-registration fee.
